



NOTICE FOR ALLOCATION TO NON-REGULATED SECTOR (NRS) FSA CONSUMERS (RAIL MODE) FOR MAY 2025

1. All Non-Power consumers having valid FSA with ECL and drawing coal under rail mode are hereby notified to submit an online rail program through FOIS for the month of MAY 2025 schedule. Consumers are also requested to mention the Contract Number and to select respective category while filing Annexure C in FOIS.
2. Proforma Invoice (PI) shall be raised by 17/05/2025 as per MSQ (in terms of rake load) and consumers shall be required to make payment through Banking Interface/RTGS in SBI Account within 48 hours of generation of PI. Consumers are requested to check the registered e-mail id/banking portal for details regarding receipt of PI. Alternatively, consumers may opt for One MSQ scheme as per extant guidelines from CIL.
3. Further, consumers are required to submit a covering letter specifying details of FSA, rail program and deposition of coal value at Rail Operations Section of M&S Dept, ECL HQ by 21/05/2025.
4. Non-submission of rail program; non-submission of required documents; non-payment shall be considered as Deemed Delivery.
5. For taking allotments as per CIL guidelines for desirous consumers in cases where pending value paid arrear allotment(s) is/are more than one-month MSQ, notarized affidavit along with undertaking needs to be submitted by the consumer for maintaining the advance payment equivalent to one-month MSQ at any given point of time (over & above the financial coverage) and that the payment for the unpaid arrear allotted rake would be deposited before actual loading. Consumers opting for One MSQ Scheme are also requested to deposit coal value before movement of rake to maintain the advance payment equivalent to one-month MSQ at any given point of time (over & above the financial coverage).
6. Process of deciding seniority of rakes for the concerned Month will be as follows:
 - a. Consumers opting for paying commensurate/full coal value
 - b. Consumers opting for one MSQ scheme
 - c. ECL reserves the right to change the sequence of seniority of rakes at the time of allotment to optimize dispatch
