Tasks without Medical Supervision	Tasks under Medical Supervision
Dressing wounds, cuts, sores, boils etc- both Major and Minor	Assisting doctors in the routine patient's consultation and any related procedures
Applying ointment, liniments and paints on wounds	Working under the supervision of doctor, depending on the merit of the case
Giving first aid in emergency cases	
Cleaning wounds, cuts, sores with antiseptic material	
Bandaging wounds	
Helping the patients with pain relieving drops in eyes, nose or ears	
Preparing patients for operations namely: shaving, giving enema etc, catheterisation of male patient if required	
Helping the patients with Pre and Post operative care	
Dressing of female patient, to be done by a female dresser	
If female dresser is not available, dressing of female patient to be done in presence of ward sister by a male dresser
